Methods and materials for containment and cleaning up

1	Absorb spilled material in dry sand or inert absorbent. In case of large amount of spillage, contain a spill by bunding.
2	Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
3	Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.
